I. Personal data we collect

Depending on the relationship, we may process: (a) identification and contact data; (b) work-related data; (c) billing and tax data; (d) financial data strictly necessary for payments/collections. We generally do not require sensitive data; if needed, we will obtain express consent.

II. Purposes

A) Necessary purposes (generally not requiring additional consent when tied to our relationship): quotations; service delivery and support; project administration; customer support; billing, collections, and legal compliance.

B) Purposes requiring your consent: marketing, advertising, promotional outreach, invitations to events, and commercial profiling (non-automated).

III. Consent and withdrawal

You may withdraw consent at any time by emailing notificaciones@transgenia.org with the subject “Consent withdrawal”. Withdrawal has no retroactive effect.

IV. Limiting use/disclosure

To limit use/disclosure (including marketing opt-out), email notificaciones@transgenia.org indicating your name, contact method for response, and the requested limitation.

V. ARCO Rights (Access, Rectification, Cancellation, Objection)

You may exercise ARCO rights by emailing notificaciones@transgenia.org or submitting a request at our address. Requests should include identity/representation proof, a clear description of the data and the right you wish to exercise, and any elements that help locate the data.

VI. Processors and transfers

We may use third-party processors (e.g., technology, hosting, messaging, invoicing) under our instructions and safeguards. Where consent is legally required for transfers, we will inform you and obtain the applicable authorization.

VII. Security and retention

We maintain reasonable administrative, technical, and physical safeguards. We retain data only as long as necessary for the stated purposes and legal obligations, then delete, block, or anonymize when appropriate.
